### 1. General issues

In what follows we explain our Privacy Policy of on line Offers, available on the site <a href="www.greenvillage.ro">www.greenvillage.ro</a> or by our agents.

By "Offer" we understand our activity, which may consist in one or several services such as: providing accommodation services for holidays and short-term periods, parks for mobile homes, camping areas and retreats, catering for events, organisation of packages consisting of travel services, excursions, events etc. which are offered and traded through tourism agencies or directly by our representatives, such as booking, brokering and sales of travel services, excursions, transport and accommodation, wholesale or retail, to the general public and/or commercial customers. Our offers are not destined for contracts completed for persons who are not 18 year-old.

#### 2. Presentation

Green Village Resort complies with confidentiality and will process personal data in technical and operational conditions of adequate security, according to the Policy of Data Processing, adopted according with Regulation (EU) 2016/679 ("GDPR").

With this document we want to inform, you in relation with (i) the nature of personal data that we process for our on line and off line Offers, (ii) the purpose of processing and (iii) legal grounds of processing.

# 3. GDPR Responsible

## 4. Personal Data

Any information relating to an identified or identifiable natural person represent personal data.

A person is considered to be identifiable if identification can be made directly or indirectly, especially by referring to an identification item, such as name, surname, identification number, localisation data, an on line identifier or one or several specific items, belonging to his/her physical, physiological, genetic, psychic, economic, cultural or social identity. Information that cannot be associated to your identity (such as number of visualisations of one Offer or other statistic data) are not personal data.

Generally, you may consult our Offers without disclosing your personal data.

We collect personal data directly from the data subjects in general. Whether your data were provided to us by a third party or have reached us by mistake, you have at your disposal all remedies provided by law to this purpose, in order to delete the data.

## 5. GDPR Data Storage

Your data are stored by our means, on special protected servers. Data are protected by technical and organization measures that we took in order to prevent loss, unauthorised deletion, access, amendment and distribution. The access to your data is permitted only to a limited number of authorized persons. Authorized persons are responsible of technical, commercial or operational management of servers and of the Activity.

Your data who are transmitted through Internet are encrypted. We use SSL certificate (Eng. Secure Socket Layer) for data transmission.

### 6. Legal grounds of processing

Whether we obtain your consent to process personal data, article 6 para. (1) letter a) of GDPR serves as legal grounds for our processing.

Whether we process personal data as these are necessary for us in order to carry out a contract or in a quasi - contractual frame (for instance in order to send you a personalised Offer, suitable for your needs) then article 6 para. (1) letter b) of GDPR serves as legal grounds for our processing.

Whether we process personal data in order to fulfil an obligation that we have, according to the law, then article 6 para. (1) letter c) of GDPR serves as legal grounds for our processing.

Article 6 para. (1) letter f) may serve as legal grounds whether personal data processing is necessary in order to serve a legitimate interest of Green Village Resort or of a third party only to the extend in which your fundamental interests, rights and liberties are not affected.

By this Data Processing Policy we will present punctually which are our legal grounds for each of the processed personal data categories.

### 7. GDPR Data Deletion

In general, we delete personal data if these were processed for one purpose that has been reached. However, some personal data may be the subject of storage obligations for certain amounts of time, according to applicable legal provisions. Green Village Resort deletes or blocks access to personal data in safe conditions until the completion of the respective time intervals.

#### 8. Cookies Use

We use cookies in order to personalize the content and announcements and in order to analyse traffic. In addition, we provide to our social networks, publicity and analysis partners information on the manner in which you use our website. These can combine them with other information provided by you or gathered after you used their services. In case you choose to continue using our website, you agree with the use of our cookie modules.

## 9. Data processing when submitting the candidature

You have the possibility to apply for one of the open positions for hire in Green Village Resort by using e-mail addresses provided on the website. Upon receiving a candidature, your documents are send using electronic means of communication. Whether your professional profile such it results from the transmitted documents does not comply with any open position within our organisation, then the documents transmitted will be deleted from our records within 6 months from the end date of recruiting process.

Anyway, you have the possibility during the time interval established for the storage of documentation to exercise any of the rights that we guarantee to the persons of interest, according to the law, as they are detailed in this Policy.

In the context of submitting your candidature, the legal grounds of processing are based on your consent and are regulated by Art. 6 para. (1) letter a) of GDPR.

### 10. Communication

#### Contact

We will use personal data such collected, exclusively for the purpose to reply to your requests or in order to remedy the matter at hand through any of these means.

These data will be processed for the purpose of eventual further references for a length of 12 months from the date of the application s solving. Anyway, you have the possibility during the time interval established for the storage of documentation to exercise any of the rights that we guarantee to the persons of interest, according to the law, as they are detailed in this Policy.

The circumstances in which such requests create obligations of a commercial or fiscal nature in our charge are exception to the length of processing mentioned above. In such circumstances, relevant personal data to deal with the request will be kept in compliance with the applicable legal time limits.

The legal grounds of processing personal data within communications with us are the provisions of Art. 6 para. (1) letter b) of GDPR.
